Montecito Bank & Trust Sweepstakes OFFICIAL RULES

Montecito Bank & Trust ("MB&T") is hosting a Small Business Month Sweepstakes (the "Sweepstakes"). References to "Sponsor" shall mean MB&T. Through this Sweepstakes, individuals can enter to win individual prizes. The Sweepstakes shall be subject to these Official Rules, and by entering, all participants agree to be bound by the terms and conditions herein.

NO PURCHASE NECESSARY TO ENTER.

1. **HOW TO ENTER**: To participate, pick up a sweepstakes card at any MB&T branch or print a copy from MB&T's website at Montecito.bank/LocalBiz (Administrative offices and ATM locations will not have sweepstakes cards available). Sweepstakes cards will only be available for pick-up during normal branch business hours which are weekdays, excluding holidays, 9:00 am - 6:00 pm (all times Pacific Time), except for the Camarillo branch which is open 9:00 am - 5:00 pm, the Mesa branch which is open from 9:00am – 1:00 pm, Monday – Thursday and the Maravilla branch which is open Monday – Friday from 10:00 am – 2:00 pm ("Branch Business Hours").

The sweepstakes card has 18 boxes with corresponding clues leading to small businesses in Santa Barbara & Ventura Counties. Solve the clue, visit the business and present the card to the business to get a stamp in the appropriate box. Participants can only collect one stamp from each participating business (even if the business has multiple locations). Participants will receive one entry for every 3 boxes that are properly stamped. Participants can submit only one sweepstakes card but can receive extra entries by posting pictures on their Facebook page at the different businesses visited. Posting guidelines: In order to receive credit for posting a picture, the post must be set as public, tag @montecitobank in the post and use the hashtag #MBTLovesLocalBiz. These extra entries are limited to one post per business per day. Participants will receive an entry for each social media post that follows the posting guidelines. Participants who get all eighteen stamps may also receive a prize, as described below.

All sweepstakes cards must be received by 6:00 p.m. on May 31, 2018, to be eligible for the Sweepstakes. Sweepstakes cards must be submitted in an official entry box at any MB&T branch during Branch Business Hours or mailed to 1010 State St, Attn: Marketing Department, Santa Barbara, CA 93101 (postmarked by May 31). Entry information on sweepstakes cards must be handwritten and may not be mechanically, electronically, photographically or otherwise entered on the sweepstakes card and participants who submit a sweepstakes card in violation of this rule will not be eligible to win. Sweepstakes card information to be provided by participants includes: name, address of residence, phone number, email and Facebook Profile Name. (Sponsor will not share your personal information unless you are a winner in which event Section 8 below will apply.)

2. **START/END DATES**: The Sweepstakes begins at 8:00 a.m., May 1, 2018 and ends at 6:00 p.m., May 31, 2018.

3. **ELIGIBILITY**: The Sweepstakes is open only to individuals who are at least 18 years of age and reside in Santa Barbara or Ventura County. Entries from individuals residing in other locations will not be eligible and will be removed from the Sweepstakes. Winners may be required to provide evidence that they reside within said counties.

Employees of the Sponsor or its parent company, affiliates, subsidiaries, advertising or promotional agencies, and immediate family members (and those living in the same household) of such an employee are not eligible. This offer is subject to all laws and void where prohibited by law. Additionally, each participant who submits a sweepstakes card with proper stamps in all eighteen (18) boxes will receive one Scavenger MVP Prize provided, however, each participant can win only one Scavenger MVP Prize. Prizes will be distributed 4-6 weeks after selection of the winner. No cash value, no substitution for prizes. Winners will be responsible for any federal, state, and local taxes.
